<p>Annwyl Syr/Madam,</p> <p>Cynllun Datblygu Lleol Diwygiedig Rhondda Cynon Taf</p> <p>Mae'n bosibl eich bod yn gwybod bod Cyngor Rhondda Cynon Taf wedi dechrau paratoi Cynllun Datblygu Lleol (CDLI) diwygiedig ym mis Medi 2020.</p> <p>Mae cryn dipyn o waith wedi'i wneud ar baratoi'r CDLI diwygiedig ers hynny, a hyn drwy gydol pandemig COVID-19. Serch hynny, cafodd y pandemig a'r cyfyngiadau cysylltiedig effaith andwyol ar baratoi camau cychwynnol yr adolygiad yma.</p> <p>O ganlyniad i'r uchod, yn anffodus doedd dim modd i ni gyflawni'r amserlen mewn perthynas â'r dyddiad cau ar gyfer cyhoeddi ein Strategaeth a Ffeyfrir ar gyfer y CDLI diwygiedig ym mis Tachwedd 2021, fel sydd wedi'i nodi yn y Cytundeb Cyflawni ffurfiol. Rydyn ni wedi ystyried yn fanwl nifer o ffurdd i fynd i'r afael â hyn.</p> <p>Cynllun Datblygu Lleol Diwygiedig Arfaethedig Rhondda Cynon Taf 2022-2037</p> <p>Yn unol â hynny, mae'r ateb mwyaf priodol wedi'i gynnig (ond heb ei gytuno'n llawn eto gan Gyngor RhCT), sef atal gwaith baratoi'r CDLI diwygiedig presennol a dechrau paratoi CDLI diwygiedig newydd. Byddai cyfnod y cynllun yma'n 15 mlynedd – o 2022 tan 2037.</p> <p>Er mwyn gwneud hyn, mae angen i ni baratoi Cytundeb Cyflawni newydd. Mae Cytundeb Cyflawni yn nodi amserlen ar gyfer paratoi'r Cynllun gan gynnwys pryd y byddwn ni'n ymgynghori â rhanddeiliaid ar wahanol adegau, yn ogystal â Chynllun Cynnwys y Gymuned sy'n nodi sut y byddwn ni'n ymgynghori â chi. Rydyn ni wedi paratoi Cytundeb Cyflawni Drafft ar gyfer CDLI diwygiedig arfaethedig 2022–2037.</p>	<p>Dear Sir/Madam,</p> <p>Rhondda Cynon Taf Revised Local Development Plan</p> <p>As you may be aware, Rhondda Cynon Taf Council began preparing a Revised Local Development Plan (RLDP) in September 2020.</p> <p>Considerable work has been undertaken on the preparation of this RLDP since then and this throughout the COVID-19 pandemic. However, the pandemic and the associated restrictions had a detrimental effect on the preparation of these initial stages of the revision.</p> <p>As a result, regrettably, we have been unable to meet the deadline of publishing our Preferred Strategy of the RLDP in November 2021, as is set out in the formal Delivery Agreement. Solutions have been considered in depth to address this.</p> <p>Proposed RCT Revised Local Development Plan 2022 – 2037</p> <p>Accordingly, the most appropriate solution has been proposed (but not yet fully agreed by RCT), to stop the preparation of the current RLDP and to begin preparation of a new Revised LDP. This would have a 15-year plan period from 2022 to 2037.</p> <p>In order to do this, we need to prepare a new Delivery Agreement. A Delivery Agreement sets out a timetable for the plans production, including when we will consult stakeholders at various stages and a Community Involvement Scheme, which tells you how we will consult you. We have prepared a Draft Delivery Agreement for the proposed RLDP 2022 – 2037.</p> <p>We would welcome comments on any part of the Delivery Agreement over the next three weeks, and request that you please submit any</p>
