#### **Quality/Environment**

- Complaints 1 x Noise possibly related to a Bulk tanker blowing into silo 7,

- Use of alternative fuels regularly at around 90% level.
- The Carbon Capture is in operation and the trial is underway.
- Planned Shutdown from 19/08 23/09, main task is the installation of new duct top of tower. One piece lift, crane assembly commences 21st August.

#### 4.0 **Environment Agency**

- Loss of containment of 10-15l of grinding aid on site.
- EA will be auditing the site Climate Change Risk Assessment later in the year. EA to forward the audit template to site.
- C-Capture unit for carbon capture ongoing.
- No complaints to EA.

#### 5.0 Rutland County Council

Local Plan review in progress. Expected next formal consultation (Regulation 19) will commence October 2024.

#### 6.0 <u>Ketton Parish Council</u>

- Rutland Quarry Forum would like to talk to us about PM10 levels at Greetham
  Quarry (Mick George). RQF working with Ocado regarding PM10 monitoring /
  levels. They want to set a meeting to discuss PM10 levels and monitors. Currently
  Mick George are still operating as a separate entity to HM, for discussion with HM
  Steve Morton is the best contact. Mary Cade will be sending the reports to Kevin
  Burton.
- Leasing of land by KSCC on Pit Lane (field opposite KSCC entrance) this field is currently leased to R & R Mills, top football field wish to improve drainage and have a grant for this work, lease due for renewal in 2027. # 8.0 Quarry Future Plans Proposed Quarry Extensions (Northwest land and Field 14)

KP left the meeting prior to update on planning application.

- HM to review all objections and prepare responses, this expect to be completed in a few weeks.
- EHO Additional noise monitoring has been carried out in the last two weeks alongside the A606. HM confident can meet statutory limits.
- Anglian Water has an objection to the extension. Concern is on their 3m tunnel feeding Rutland Water than runs alongside the A606. HM in discussion with AW to address the concern.
- Local MP wrote to M Gove for the application to be called in due to the impact on Rutland water, HM wrote to Mr Gove stating that the application should be assessed by RCC. We will invite MP to the site.
- Recent (June 2024) Supreme court judgment (the Finch case) regarding the EIA for CO2 down stream of process. HM considering the implications of Finch (which relates to an on shore oil well) on the planning application and associated EIA for the NW land and F14.
